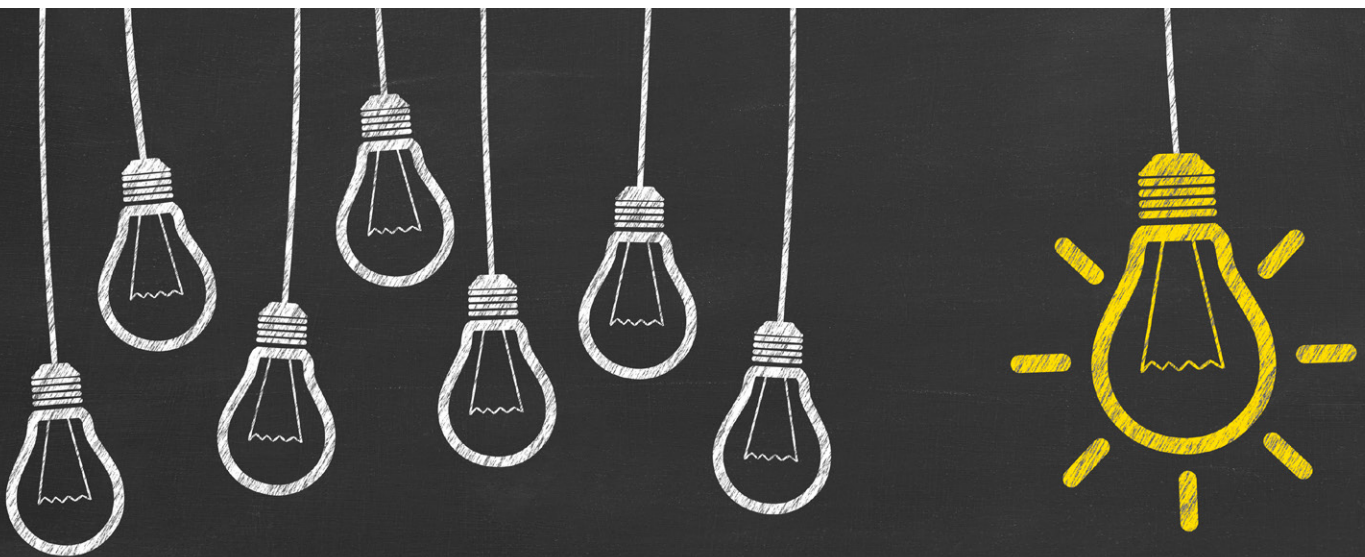

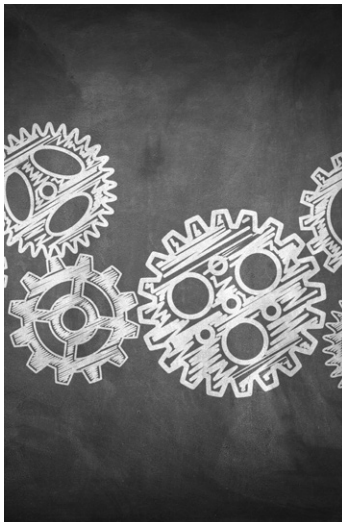

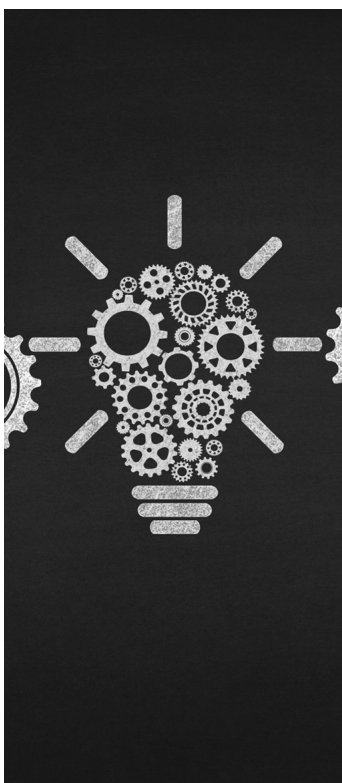
## Be Commercial
